Mollie Cordo from the Florida Department of Environmental Protection's (DEP) Office of Resilience and Coastal Protection welcomes the room and asks all to stand and recite the Pledge of Allegiance. ### **Commission Procedural Items**

#### **Water and Sewer Department**

Amanda Kinnick, interim director of Miami-Dade County's Water and Sewer Department, provides a presentation on the county's efforts to comply with the Ocean Outfall Legislation, including work at the Central District Wastewater Treatment Plant, 2024 sanitary sewer overflows and other initiatives such as the consent decree projects and Connect 2 Protect.

The commissioners discuss the complexities of managing wastewater in Miami and need for additional funding to support the Water and Sewer Department.

## **Environmentally Endangered Lands Program**

Janet Gil, director of Miami-Dade County's Environmentally Endangered Lands Program, presents a general program overview, including recently acquired lands, proposed acquisitions and upcoming events.

The commission discusses federal and state funding opportunities, how the Environmentally Endangered Lands Program prioritizes new projects and opportunities for state acquisition of public lands.

### **Stormwater and Canal Management**

Matahel Ansar and Richard Virgil from the South Florida Water Management District (SFWMD) provide updates on the SFWMD's water control structures, marine debris control efforts and management practices around South Florida and Biscayne Bay.

The commission discusses direct stormwater outfalls into canals and opportunities for SFWMD collaboration with Miami-Dade County, as well as temperatures and salinities of Biscayne Bay over the past year.

#### **Biscayne Bay Water Quality Improvement Grant Program**

Mollie Cordo, representing the Florida Department of Environmental Protection, gives a presentation on the Biscayne Bay Water Quality Improvement Grant Program, highlighting the new <u>Fiscal Year 2024-25</u> <u>award recipients</u> and how their projects will benefit the bay.

Commissioner Blalock encourages organizations to continue applying for this and other grant opportunities administered through DEP.

  - Discusses new methods to enhance asset management in the Biscayne Bay Aquatic
     Preserve; requests increased local funding for the county's Environmentally Endangered

Lands Program and additional funding for the Indian River Lagoon; and supports nutrient source point reduction from golf courses and nutrient reduction projects by the SFWMD.
